Sl. No.	The school is directed to ensure that:
1	The total number of sections of Bal Vatika shall be restricted to 3 (Two sections each in Bal Vatika I, II & III respectively). The total number of sections of the school from class I to XII shall be restricted to 15 of which not more than 1/3rd sections may be used for senior secondary classes. The number of students in each section shall be restricted to 40. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension.
2	The school does not have lift/ramp to access upper floor. Hence, the school is required to construct ramp/lift to access upper floor and submit compliance on SARAS portal within 3 months.
3	The composite lab is not properly laid out. Moveable wooden tables have been placed in the middle of the room with few chemicals which is an inappropriate and unsafe arrangement for conducting chemistry practicals. There are no stone/steel topped work stations with inbuilt utilities (gas and water supply) for bio and chemistry sections and no lab standard tables for Physics section. Physics lab does not have lab standard tables. It is under-stocked with little equipment placed on wooden tables. Biology Lab has a temporary set up without any workstation with inbuilt utilities. Apparatus/equipment has been placed on the table. Adequate arrangements for storage

	of material have also not been made. Thus, the school is required to upgrade all the lab as per the Board's SoP within 03 months and submit videographic evidence in the compliance.
4	School should replace wooden tables with metal/stone top, plastic stool with wooden/metal stools used in all the lab and submit compliance on SARAS portal within 3 months.
5	Math lab does not have proper workstations. The storage facility is inadequate. School is required to update the lab as per SoP issued by the Board and submit compliance on SARAS portal within 3 months.
6	Out door playing area is not properly developed. The school shall upgrade the outdoor sports facilities as per SoP issued by the Board within 3months and submit compliance on SARAS with videography.
7	The school shall conduct training of its teachers with CoE Pune within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- 1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
- 8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
